Important Information

- A Small site is 3m x 3m, a Large site is larger than 3m x 3m, please indicate the actual large size of the site you require.
- Social Membership is included in the site fees – one with Small Site, two with Large Site. Additional Social Memberships can be purchased in advance or when arriving at the site.
- There is very limited power available at the site – it is highly recommended that you bring a generator sufficient for your own power needs. There is access to bore water at the site, but no drinking water other than bottled water for sale.
- Showers & Toilets are available on site and use of these and camping is included in your Social Membership.
- All Exhibitors must report to the Secretary's Office or Site Coordinator prior to any site setup commencing. The site will be open for setup from Wednesday 16th June 2010, 10am and close on Monday 21st June 2010 at 3pm.
- PAYMENT must be received in full by the 1 May 2010. Payment can be lodged by cheque with this form or bank details available on request. Tax Invoices will be posted/emailed to the address provided. All figures stated include GST.

TERMS AND CONDITIONS OF PARTICIPATION IN EVENTS HOSTED BY ABC AMATEUR RACE CLUB INC

1. The ABC Amateur Race Club reserves the right to limit the number of exhibitors.
2. The participant shall comply with all relevant laws affecting its participation. In the case of exhibitors providing food and drink all relevant health laws must be met.
3. The participant shall take out public liability insurance with a limit of liability no less than ten million dollars and indemnifies and will indemnify the organiser, its agents, servants, contractors, and employee from all actions, claims, demands, losses, damages, costs and expenses arising from the participant's use of the site and in particular but without limiting the generality of the foregoing against any loss, damage or injury from any cause whatsoever to the property or person caused by the use of the site by the participant or any servant, agent or other person duly authorized by the participant whether such loss, damage or injury occurs on the site or not and whether caused by an act, omission, neglect, breach or default of the participant or any other person.
4. The participant shall not, without the prior consent of the organiser, permit any person other than the participant, its servants or agent to occupy any part of the site. Should this condition not be observed, the organiser may charge an additional fee for basic package or exercise any other of its rights under this agreement.
5. The organiser reserves the right to cancel this agreement and to retain any money paid and to recover any money not paid in relation thereto without assigning any reason for such cancellation and retention or recovery.
6. The organiser reserves the right, if it considers it to be expedient or desirable to do so, to cancel or to postpone the operation of this agreement by notice in writing in the event of any occurrence or happening which in the opinion of the organiser justifies it in so doing. The participant indemnifies the organiser against any claim for compensation or damages or any other action or demand, whether on the ground of loss of profits or otherwise arising from such cancellation or postponement and acknowledges that in such circumstances the organiser shall be entitled to retain any money paid or to recover any money not paid by the participant in relation to this agreement.
7. The organiser reserves the right to cancel this agreement and retain any money paid or to recover any money not paid in relation thereto if there is in the opinion of the organiser any infringement of any of the terms and conditions of this agreement or if the exhibitor does not occupy its space at the commencement of and during the full period of the exhibition.
8. All property of the participant is brought on to the ABC Amateur Race Club grounds at the risk of the participant and the participant hereby agrees to indemnify and hold indemnified the organiser against any action, claim, demand, loss, damage, cost or expense in relation to any loss, damage, or injury to such equipment however occasioned.
9. The organiser reserves the right to alter allocations at its discretion.
10. The participant shall pay all site fees and advertising charges to the organiser by the last trading day in April as indicated in "Important Information" of the same year.
11. The organiser shall be responsible only for the provision of the services specified on the front of this booking sheet, and does not warrant providing any other services whatsoever.
12. In this agreement, unless the context requires otherwise:
 - "The Organiser" wherever appearing shall include ABC Amateur Race Club Inc, its servants and agents.
 - Words importing the singular shall be deemed to include the plural and vice versa; words importing the masculine gender shall include the feminine and neuter gender as the case may require and words importing the neuter gender shall include the masculine and feminine gender as the case may require.
 - When two or more persons are parties to this agreement the terms and conditions herein contained shall bind them jointly and each of them separately and each of their respective executors, administrators and assignees and when a company is a party hereto the terms and conditions on its part herein contained shall bind the company, its successors and assignees.
